### Statement of Affiliation

Our Chapter, in consideration for being granted affiliation with **Full Gospel Business Men's Fellowship in America**, hereby agrees, declares and affirms as follows:

1. The Chapter adopts and adheres to the Doctrinal Statement and all other Sections of the Bylaws of the **Full Gospel Business Men's Fellowship in America** as shall be amended and adopted from time to time by the National Council of Delegates.
2. The Chapter is organized exclusively for religious and educational purposes and shall operate in accordance with the requirements of Section 501(c)(3) of the Internal Revenue Code, including [a] provisions that prohibit political activities, [b] provisions that regulate charitable gaming, issuance of bonds, various housing programs, and charter and private schools, and [c] provisions that prohibit payments to Members or Officers, except the Chapter shall be authorized and empowered to make payments to Members or Officers in accordance with the 'Conflict of Interest Policy' for *bone fide* services rendered, goods purchased, or expenses incurred for the exclusive benefit of the Fellowship. Further, the Chapter agrees that, if it conducts or enters into any of the activities listed in Paragraph [b], the Chapter shall be removed from the Group Exemption and shall be required to apply for its own determination and qualify for tax exempt status.
3. Upon dissolution of the Chapter, funds and other assets remaining after all liabilities have been paid shall be remitted or transferred to the National Office. Further, if at the time of dissolution of the Chapter, **Full Gospel Business Men's Fellowship in America** and its National Office [a] ceases to exist; [b] does not accept the distribution, or [c] is no longer exempt under Section 501(c)(3) at the time of dissolution, the assets shall then be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or shall be distributed to a federal, state or local governmental agency for a public purpose. Further, any such assets not disposed of to a governmental agency shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Fellowship is then located, exclusively for such purposes or to such organizations, as said court shall determine, which are organized exclusively for such purpose.
4. From time to time this Chapter shall submit the required financial and status reports to the National Office in such form and on such due dates as prescribed by the National Office.
5. **Full Gospel Business Men's Fellowship in America** has been granted Section 501(c)(3) exemption. In recognition of the eligibility of this Chapter to be included in the Group Exemption 5422 granted to Full Gospel Business Men's Fellowship in America, the National Office is hereby authorized to add this Chapter to its Group Exemption 5422 and to include this Chapter in its Group Exemption report to the Internal Revenue Service.
